

# NOTICE OF CHANGE OF POLLING LOCATIONS

Due to budget cuts, the Supervisor of Elections has consolidated polling places throughout Indian River County. These polling place changes will be effective for the January 31, 2012 Presidential Preference Primary Election. All voters affected by the changes will receive a notice from the Elections Office indicating their new voting place. Our consolidated polling places will be equipped with additional poll workers and increased voting equipment to efficiently process voters. Remember, this election is a Republican Primary Election. Only voters who are registered "Republican" are eligible to vote in this election.
